#### IV. <u>Treasurer's Report</u>

### a) 2021 Year-to-Date Report

Report of the Treasurer YTD Operating as of 11/30/2021 Other as of 12/14/2021

December 19, 2021

As of the end of November, our Operating Income was \$212,910 against a plan of \$209,238 (+\$3,621 or +1.7%). Of this income, Total Giving was \$148,472 against a plan of \$142,083 (+\$6,389 or +4.5%).

The Operating Expenses YTD are \$200,056. Our cash flow has been positive almost all year. The differential between Income and Expense was +\$12,854 YTD.

Although we spent all our Capital Improvement Budget for the year on an irrigation system, masonry repairs for the Parsonage, and plumbing and heating issues, the bigger challenge was the extraordinary expense of a new roof for the Education Building, along with repairs for damage to the inside of the pre-school and remediation of the resulting mold problems. This was not part of the Operating Budget for 2021. The decision was made to ask for donations to defray this large and necessary undertaking.

The cost total for the Roof and Remediation Project was \$29,898 with donations as of 12/14/21 of \$24,125 which leaves \$5,773 to come out of the remaining insurance settlement (from a storm earlier this year) or funds on hand in contingency in our Savings account.

We are so fortunate to have had many generous people step forward, which will allow us to use the remained of the insurance money to pay for the Fellowship Hall kitchen repairs that were sorely needed.

We are very blessed!
