### VI. Treasurer's Report – Karen Maust, Treasurer

# Report of the Treasurer Period ending November 30, 2022

This has been a challenging year for us at Sayville Congregational United Church of Christ. We adopted a budget at our annual meeting in 2021 based on the pledges we had at hand and assumptions of giving that proved to be unrealistic. That said, we have managed to hold expenses down (where possible) to make the real numbers work!.

Our Year-to-date operating income is \$207,678 against a Year-to-Date (YTD) plan of \$212,104.

The Pledge/giving portion of this is \$132,760 against a plan of \$146,667 (-9.5% or \$13,907).

On the expense front, the YTD total is \$190,681 against a YTD plan of \$210,678. Our cash flow is now positive (part of the year we were spending more than we took in).

As you can see from the actual details in the Year-to-Date report we have benefitted from our fundraising efforts and attention to areas that could be controlled.

In the next month we will see end of year disbursements for our Mission giving and denominational expenses in addition to the usual operating area outlays.

# VIII. 31st Victorian Tea

Sayville Congregational United Church of Christ Report of the 31st Victorian Tea, November 18 & 19, 2022

The world and the tea lost Alice Gray this year, a founding member, and keeper of all recipes and traditions. She was on our minds continually. We paid homage to her during each seating, and had a commemorative area in the sanctuary as well. Having lost Don the previous year necessitated a number of adjustments in personnel, along with the changes we had made as a result of the pandemic, such as air movement and fewer tables.

We decided to keep most of the modifications, especially when they made life easier for the committee and its many helpers. Moving the date to before Thanksgiving worked well, as did reducing sessions to only four.

Children were welcome at every seating, two on each day. We were very nearly sold out and sent goodies home to three ladies whose health prevented their attendance. We kept all our prices the same, and served around 210 meals, to rave reviews. Everyone was glad to be there, even the many workers.

We were fortunate to add two additional scone bakers, and had great staffs in the kitchen, fellowship hall, coat check, raffle ticket table, front door, dining room, set-up and clean-up crews, basket donors (from the congregation and local merchants) and the underappreciated dish washers! We treasure our biggest cheer-leader, Pastor Ray!

There were many records broken this year: Our wonderful committee is the largest it has ever been, starting at 18 before we lost Alice. This includes Cheryl Maler (Emeritus) who lives in Tennessee and paid us a surprise visit! Our harpist Lisa Kelly played for her 15<sup>th</sup> year, according to Alice's records! There were more helpers than ever, before, during and afterward. Hallelujah! Due to great generosity, we raffled off 95 baskets and gift certificates, including a priceless collection of Macy's plush collectibles donated by Pastor Ray from his 30+ years of working for the Macy's Thanksgiving Day Parade, and a model train set donated by James Cesare! Finally, we made a record amount for the church, even while our real goal is to provide a welcoming place to gather with friends and enjoy delightful treats. All goals achieved!

Unbounded thanks are due to everyone in the church and beyond who contributed in so many ways to the success of our 31st Victorian Tea. This one will be hard to top!

### X. Justice Committee

### XI. Deacon Elders

You might be asking, what are Deacon Elders and what are they supposed to do? From the appendix to our Church constitution and bylaws: "The Deacon Elders shall be responsible for all matters pertaining to Christ's mission for the church to include but not limited to worship, faith development, pastoral care, mission outreach, evangelism, and prophetic witness."

This year has been a busy year as we began transitioning back to a more "normal" worship after 2 years of pandemic restrictions. This has included how to safely resume communion in ways that allow each of us to feel both nurtured and safe.

We were able to provide a light repast after the Maundy Thursday service that was a meaningful addition to the Holy Week services. And this lead us to begin thinking of resuming hospitality after church on Sundays – and who isn't happy about that! And to make it easier to encourage volunteers to sign up to host hospitality we drew up a set of guidelines with what it entails. These guidelines are posted next to the sign up sheet in the hallway and can also be found in the eChimes.

Pat Mahar was responsible for the quilt raffle which raised money for Ukraine which supplemented our contribution to the collection we did in partnership with St. Peter and Paul Ukrainian Orthodox Church of warm clothes and blankets to be delivered to Ukraine.

And finally, in part to overcome the isolation many of us felt during the pandemic, we created a calling tree to ensure we are calling each other to check in, chat and let everyone know how much they are loved and cared for. If you are not receiving a call periodically for whatever reason please let one of the Elders know and we will make sure you get added to the list.

"Three to five Deacon Trustees shall be elected from the Covenant Membership of the Church. The Deacon Trustees shall be ordained into the deaconate and shall be responsible for all matters pertaining to corporate management of the Church and its resources to include, but not be limited to, stewardship, physical property oversight, personnel management and, in conjunction with the treasurer, the management of Church funds. Deacon Trustees, in conjunction with Deacon Elders, shall approve the hire of all staff serving in mission-related positions, including Worship Musicians and Christian Educators. Deacon Trustees shall approve the hire of all personnel in non-mission functions, to include but not be limited to those responsible for care and maintenance of physical properties. Deacon Trustees shall divide these responsibilities among themselves and shall form such teams and *ad hoc* committees as needed to fulfill their duties. The treasurer shall serve as an *ex officio* member of the deacon trustees."

We are grateful for all the support of our Trustee leaders and all the congregational friends and members who assist us in this work. We begin our new year with thanks to Tom Wolf for his exceptional service.

We welcome the next member of our leadership board and continued service to Sayville Congregational United Church of Christ.
