(Constitutional Description

¹ (Constitutional Description) The Moderator shall preside at all official meetings of the Church and of the Board of Deacons and shall work with the minister and Board to set the agenda. The Moderator acts as the liaison between members of the Congregation and all Boards and Committees. The Moderator shall serve as the President of the Corporation.

² (Constitutional Description) The Minister shall be called by a vote of at least two-thirds of the members present at an official Congregational Meeting. He or she, as pastor and Teacher, shall minister to the spiritual welfare of the Church, being receptive to the Board of Deacons for advice, guidance and assistance. The Minister shall seek to enlist individuals as followers of Christ, preach the gospel, administer the sacraments, and have responsibility for all services of public worship and administration of the activities of the Church in cooperation with the Board of Deacons and Committees. The Minister shall be an *ex officio* member of the Board and Committees.

³ (Constitutional Description) The Secretary/Clerk shall record the proceedings of the Congregational Meetings and the Board of deacons of which he or she shall be a member and secretary. The Clerk shall be responsible for giving official notice of all Congregational Meetings. The Clerk shall keep a register with addresses of the members of the Church, dates and modes of their reception and removal, a record of births, baptisms and marriages, and shall be responsible for and preserve on file all communications and written official reports including letters of transfer.

⁴ (Constitutional Description) The Treasurer shall receive an accounting of all receipts and disbursements and shall direct management of all Church funds in accordance with the policies of the Board of Deacons and the budget approved by the Covenant Members. He or she shall make a full report to the Annual Meeting and such other reports as may be requested by the Church. The Treasurer shall serve as the Chairperson of the Finance Committee as well as the Treasurer of the Corporation.

IV. Ray Bagnuolo, Pastor Comments

Friends, today you will hear and read about the life of this congregation; a congregation that is resilient and determined in loving one another and the world in which we live. For more than 175 years, *this* church on Middle Road has served *this* community and beyond in the ways you practice your faith and lives together. Your history and present; your service to one another here and online; and your radical hospitality powerfully reflect these beliefs, made stronger by the ways in which you embrace God and all who enter here.

Frequently, when I am asked by folks what we do here, I begin with, "We love one another;" – on the good days and the not-so-good days. It is that love which touches people locally and across the Internet. We often hear from visitors and newcomers about how "welcoming and warm" they feel when they are here – or visit us on our YouTube Channel. Perhaps that is what God most *feels* like: *welcoming and warm*. It certainly describes you.

And "this" is who you are, in all the ways I know you. A congregation that comes from deep places of conviction and hopefulness. People who set resignation aside and find ways to do what they can, even as you and I struggle with the slow pace of justice, a struggle that sometimes clouds the gifts of all that has been and is being done – by us all.

As you listen to these reports or read them at your leisure, think of what you have been able to do, are doing, hope to do – and then consider for a moment what would *not be happening* were you not here; not doing what you are doing. This congregation *is* present in this world– because you bring your amazing selves here and create something new, time and time again.

In the weeks ahead, you will be entering into a time creating something new; a time of reflection and discernment as you consider the path of calling your next pastor. There will be much said over the next few weeks about the process (which can begin only after I leave, according to denominational guidelines). For now, let me say that I will be sad to go. It is hard to leave the people I love and the ministry you have given me - in serving you. And yet there is such joy in what you will offer to someone on their way to you. I am joyful for you and for them. And, I believe it: "You've only just begun, again!"

Please know that my gratitude and first-hand knowledge of what it is to be called by this congregation – makes me excited for the next person who will come to know you and your beautiful hearts. In all the healing and love we have shared, please know how I have been healed by you, in ways I didn't even know I needed.

It will always be more than it is...may you see the more in these reports and all the faithful and questioning who are here, visit online and are to come at Sayville Congregational United Church of Christ.

VI. Treasurer's Report - Karen Maust, Treasurer

Report of the Treasurer Period ending November 30, 2023

The good news as we started 2023 was that we ended 2022 with several windfall donations which impacted the carry-forward amount budgeted at the 2022 Annual Meeting. The original budgeted amount was \$7,500 and ended up at \$19,888.

The Board of Deacons were able to approve the use of the additional \$12,388 to increase the Capital Improvement line to \$22,388. This enabled The Church to approve a new roof for Fellowship Hall and other needed work.

As of the end of November 2023 the Year-to-Date Total Operating Income is \$228,422 against a plan of \$228,102 (+340) Total Giving for the period is \$147,414 against a YTD plan of \$148,958(-\$1,544 or -1%).

The Expense YTD is \$220,474 against a YTD plan of \$228,102 (+\$7,628) and our cash flow is in the positive column(\$7,948).

We have weathered both figurative and actual storms (the Ed Building flood and damage). Thanks to Pastor Ray, who kept the entire project on track and very well managed, we prevailed with a good insurance settlement to address the needed repairs.

As we come into this wonderful season, we have much to be thankful for and we go forward in planning our future with hope, thanks and gratitude.

2024 – Budget Proposal Review Presented by Ray at the December Board Meeting Following the Budget Committee Proposal

General Suppositions

- 1. For the purpose of this budget, we have projected:
 - a. Pastor's Terms of Call in 2024 to remain at 2023 levels.
- 2. This budget <u>does not engage</u> in any projection of what the Search Committee will recommend at the appropriate time for the next pastor's *Terms of Call*.
- 3. We have projected the following for purposes of forming a budget.
 - a. January 2024 Current Terms of Call for Ray's last month.
 - b. February August Pulpit Supply at \$200/wk Approx. \$6,000
 - c. September December New Pastor at current Terms of Call.
- 4. Following #3's projections:
 - a. We project about \$25,000 (over the next 12 months) for five months of a pastor: (January, September, October, November, December).
- 5. Staffing and Administrative Short Summary:
 - a. Five-month Pastor over the next 12 months.
 - b. Seven-months of pulpit supply
 - c. Church Administrator position increased to 5 days a week, 7 hours a day
- 6. Following these projections:

a. 2023 Income & Expenses: \$248,838b. 2024 Income & Expenses: \$242,105

- 7. It can be said that this is a conservative budget, considering
- 8. the year ahead. If giving remains at 2023 level or above and/or if it takes longer to transition to the next pastor we improve our financial position. (Ray)

X. Justice Action Committee

As a committee, we are constantly aware of all the challenges facing our communities on a daily basis. In our small way, we are trying to shed light on foster care, immigration, sex and human trafficking, labor trafficking, gun violence, LGBTQAI+, and women's abortion rights.

This year we continued to support the youth in the Suffolk County Foster Care Program. We purchased additional Pack n' Plays for teen mothers, so they could bring home their babies to a safe, sleeping environment.

In May, we hosted a luncheon on the topic of sex trafficking. Our keynote speaker was James Johnson, a detective with the Human Trafficking Investigation Unit, Kidnap Investigation Team and FBI Child Exploitation/ Human Trafficking Task Force. Detective Johnson was responsible for closing the Sayville Motor Lodge, where the owners were compliant in trafficking young local women. In attendance there were over forty County, non-profit, state elected , judicial, library and pastoral officials. It was a lively gathering, where information and ideas were exchanged.

Presently, our committee has pivoted to support the newly formed Gun Legislation Committee. We are contacting our Congress representative and others, to encourage them to support legislation to ban assault weapons.

We will continue to be a voice for those whose voices are not heard.

XIII. Deacon Trustees

This briefly describes the role of Deacon Trustee in our Congregation, and is taken from our most recent document:

"Three to five Deacon Trustees shall be elected from the Covenant Membership of the Church. The Deacon Trustees shall be ordained into the deaconate and shall be responsible for all matters pertaining to corporate management of the Church and its resources to include, but not be limited to, stewardship, physical property oversight, personnel management and, in conjunction with the treasurer, the management of Church funds. Deacon Trustees, in conjunction with Deacon Elders, shall approve the hire of all staff serving in mission-related positions, including Worship Musicians and Christian Educators. Deacon Trustees shall approve the hire of all personnel in non-mission functions, to include but not be limited to those responsible for care and maintenance of physical properties. Deacon Trustees shall divide these responsibilities among themselves and shall form such teams and *ad hoc* committees as needed to fulfill their duties. The treasurer shall serve as an *ex officio* member of the deacon trustees."

The following is a summary of various projects that the Trustees oversaw in 2023,

- 1. Replacement of the floor, removal of the asbestos tiles and extensive repairs to classrooms in the Ed Building following a serious water break.
- 2. Replacement of the roof on the Fellowship Hall and the Preschool.
- 3. Evaluation by the Steward Preservation Services of the Church building and the repairs needed.
- 4. Replacement of doorknobs in kitchen and vestry and other areas to be more accessible.
- 5. Update of the heating system in Ed Building, including installation of a new water heater.
- 6. Reinforcement and repairs of baseboard heating covers in Preschool (thank you Barbara and Mark)
- 7. Established new relationship with Samantha and Daniel Harr, Building and Grounds support, as Laura transitions.

Our committee continues to work diligently in the many responsibilities of the Trustees and welcome the continued support of the congregation.

XV. Addendum

General Constitutional Descriptions

BOARD DESCRIPTIONS

<u>Board of Deacons</u>: The Board of Deacons is a representative body comprised of all currently serving Deacons. It shall be the final decision-making body between Congregational Meetings, working closely with the Minister in the spiritual and institutional affairs of the Church. Specifically, the Board of Deacons is charged with ensuring the resources of the church are utilized in a manner consistent with Christ's mission for the church and in accordance with this Constitution and By-Laws. The Board of deacons shall consist of three to five Deacon Elders, three to five Deacon Trustees, and the three elected officers of the Church. The Board of Deacons shall meet regularly as needed, not to be less frequent than once a quarter. The Minister shall serve as an *ex officio* member of the Board of Deacons.

<u>Deacon Elders:</u> Three to Five Deacon Elders shall be elected from the Covenant membership of the Church. The Deacon Elders shall be ordained into the deaconate, and shall be responsible for all matters pertaining to Christ's mission for the Church, to include, but not be limited to: worship, faith development, pastoral care, mission, outreach, evangelism, and prophetic witness. Deacon Elders shall, in conjunction with Deacon Trustees, approve the of all staff serving in mission related positions, including Worship Musicians and Christian Educators. Deacon Elders shall approve all mission partnerships with outside organizations. Two Deacon Elders and the Minister shall receive requests for and approve disbursements of funds from the Deacons Fund, in accordance with the policies set down by the Board of Deacons. Deacon Elders shall divide their responsibilities among themselves, and shall form such teams and *ad hoc* committees as needed to fulfill their duties. The Clerk shall serve as an *ex officio* member of the deacon Elders.

<u>Deacon Trustees</u>: Three to five Deacon Trustees shall be elected from the Covenant membership of the Church. The Deacon Trustees shall be ordained into the deaconate, and shall be responsible for all matters pertaining to corporate management of the Church and its resources, to include, but not be limited, stewardship, physical property, personnel management and, in conjunction with the treasurer, the management of funds. Deacon Trustees, in conjunction with Deacon Elders, shall approve the hire of all staff serving in mission-related positions, including Worship Musicians and Christian Educators. Deacon Trustees shall approve the hire of all personnel in non-mission functions, to include but not be limited to those responsible for care and maintenance of physical properties. Deacon Trustees shall divide these responsibilities among themselves and shall form such teams and *ad hoc* committees as needed to fulfill their duties. The treasurer shall serve as an *ex officio* member of the Deacon Trustees.

NOMINATING COMMITTEE

Nominating: The Nominating Committee shall prepare and present to the Congregation a slate of candidates nominating one person for each Church office to be filled. Candidates for the Nominating Committee itself shall be recommended by the Board of deacons. The entire slate of candidates should represent the diversity of the Congregation with respect to race, age, gender, sexual orientation, and duration of Church membership. The Nominating Committee shall keep the Congregation informed as to which positions are vacant, and the responsibilities thereof. If a vacancy in any Church office or Board exits in the period between Congregational Meetings, the Nominating Committee shall recommend candidates to the Board of deacons for appointment. At all times, the Nominating Committee and the Board of Deacons shall make every effort to consider the spiritual gifts of particular individuals in filling positions.

ELECTION OF OFFICERS AND COMPOSITION OF BOARDS

Section I: Length of Election

A. Officers

- 1) The Minister shall be called for an indefinite period of time at a Congregational Meeting called for this purpose.
- Moderator, Secretary Clerk and Treasurer shall be elected for one year at the Annual Meeting and may be reelected.
- 3) Deacon Elders and Deacon Trustees shall be elected to two-year terms, and may be reelected.
- B. Members of the Nominating Committee may serve for one year and may be reappointed.

Members of the Pastoral Relations Committee may serve for two years and may be reelected until there is a change in ministerial staff.

Section II: Eligibility for Election

Only Covenant Members in good standing of this Church may hold elective positions.
